The Mine is owned by the Minerals Development Company Botswana (MDCB) a mining investment entity of the Government of Botswana. Morupule Coal Mine is located 7 km northwest of the urbanised village of Palapye (the fastest growing centre outside the capital city of Gaborone), along the Serowe-Palapye national highway (A14). The company's vision is 'To be a partner of choice in the global coal transition'.

Morupule Coal Mine's mining operation uses conveyor belts to transport coal from underground sections to the surface plant for processing. the mining operations are separated into two parts, inbye consisting of only the sectional belts and outbye consisting of trunk belts. outbye belts are run by variable speed drives which are plc controlled integrated to the belts control system (elt) while inbye belts are locally controlled by the belts control system. As MCM strives for zero harm, it is noted that these belts do not have belt misalignment switches, and this poses the below risks.
