
INVITATION TO TENDER

As part of the Citizen Economic Empowerment Programme (CEEP), Morupule Coal Mine (MCM) is pleased to invite tenders from well-established, citizen-owned companies for the following projects. This Invitation to Tender (ITT) supports local industry development and inclusive economic growth, enabling citizen-owned enterprises to contribute to MCM's operational needs and Botswana's sustainable development. By facilitating these opportunities, MCM reinforces its commitment to transparency, fair competition, and community empowerment through supply chain engagement.

MCM invites interested companies to tender for the following projects:

1. Manufacturing and Supply of Dust Suppression for Morupule Coal Mine – MCM-MIN-01-0030-2409-CF-0

The scope of work (SOW) for this tender includes the manufacturing, supply, and delivery of a ready-to-use dust suppression chemical for a period of **60 months**. The successful bidder must demonstrate the capability to produce, supply, and deliver a minimum of 30,000 litres of the dust suppression chemical monthly. The mine has a maximum storage capacity of 30,000 litres, and the Contractor will be responsible for managing the storage tanks on site. Compliance with ISO 14001 (Environmental Management) and ISO 45001 (Occupational Health and Safety Management) standards is mandatory. Interested bidders are invited to submit their proposals in accordance with the outlined specifications and requirements.

2. Manufacturing and Supply of Lubricants – MCM-ENG-00-0038-2409-CF-0

The scope of work (SOW) for this tender includes the manufacturing, supply, and delivery of a ready-to-use Lubricants for a period of **60 months**. Mining is an asset intensive industry which relies heavily on machinery to achieve production goals. The maintenance of these machines is very important as it ensures that they achieve their useful life. Lubrication of machinery form part of preventative maintenance activities aimed at ensuring that machine run through their useful life to bring value to the business. It is against this background that Morupule Coal Mine (MCM) invites citizen owned companies to manufacture and supply lubricants to its operation. Interested bidders are invited to submit their proposals in accordance with the outlined specifications and requirements.

3. Manufacturing and Supply of Conveyor Belt Structure – MCM-MIN-01-0026-2409-CF-0

The scope of work (SOW) for this tender includes the manufacturing, supply, and delivery of Conveyor Structures for a period of **60 months**. The conveyance system is vital to transporting coal from the working sections to the treatment plant. However, belt structure components get worn out due to the load of coal transported for extended durations and normal wear due to friction and require prompt replacing so that the conveyance system runs smoothly during production hours. Developing of new mining panels also requires additional structure to be erected to facilitate the development. The components required to this effect are ones compatible with 900mm, 1350mm and 1500mm wide conveyor. Interested bidders are invited to submit their proposals in accordance with the outlined specifications and requirements.

4. Supply of Tyres and Provision of Tyre Management Services – MCM-ENG-02-0032-2409-CF-0

The scope of work (SOW) for this tender includes the supply of tyres and provision of tyre management services for a period of **60 months**. Mining is an asset intensive industry which relies heavily on machinery to achieve production goals. The maintenance of these machines is very important as it ensure that they achieve their useful life. Tyre management is a critical part of safe, productive mining operations. Tyre maintenance assist mining operations to avoid costly downtime, improves safety and lead to increase efficiency. The scope is summarised as follows:

1. Supply of tyres and accessories to MCM.
2. Set-up a vendor-managed store for onsite storage of tyres and consumables.
3. Provide onsite Tyre fitment services for equipment on surface.
4. Perform Tyre repairs and preventative maintenance services.
5. Conduct Tyre performance monitoring and reporting.
6. Provide and install the necessary structures to manage the tyre workshop.

5. Construction of Fuel Storage Facility plus Supply & Delivery of Fuel complete with management systems - MCM-SCM-05-0036-2409-CF-0

MCM wishes to establish a contract with a reputable and experienced supplier with experience in Import and wholesale of Petroleum Products for the Design, Build, Manage and Operate of Fuel systems. The scope is summarised as follows for a duration of **60 months**:

Construction of a new diesel storage facility complete with a covered fuel dispensation station suitable for both EMV and LDVs for Open Cast and Underground Machinery. Maintenance services and installation of fuel management system. Supply and Delivery of Fuel to MCM operation. There should be provision for MCM to install its own fuel management system for quality assurance purposes.
